As the Human Rights Association (IHD) Adana Branch, we think that this table about the Kurdish children reflects democratic situation in Turkey. According to our data, 67 children under 18 and 15 years old were sentenced to 290 years and 3 months imprisonment after reductions during the 11 months period from 3<sup>rd</sup> June 2008 to 28<sup>th</sup> April 2009.

This table proves that Adana is a place like a hell for children. These children were dangerous for the future. Marbles in their pockets, sling shots, stones that they threw to police forces, and their slogans were very dangerous for this country. A Turkish proverb says "a snake must be killed when it is little". There is attempt, in accordance with this mentality, to destroy a young generation in prisons because they are children of a people which is declared as terrorist and they are dangerous for the rulers. The officials do not want to see this horrible table. This table does not attract anyone's attention. We think that if Kurdish children had shouted that we are Palestinian children, they would have attracted attention of the state authorities especially the Prime Minister, Mr. Erdogan.

The President of IHD Adana Branch, Mr. Ethem Açıkalin called on the public opinion to do something about this pressures against Kurdish children.
